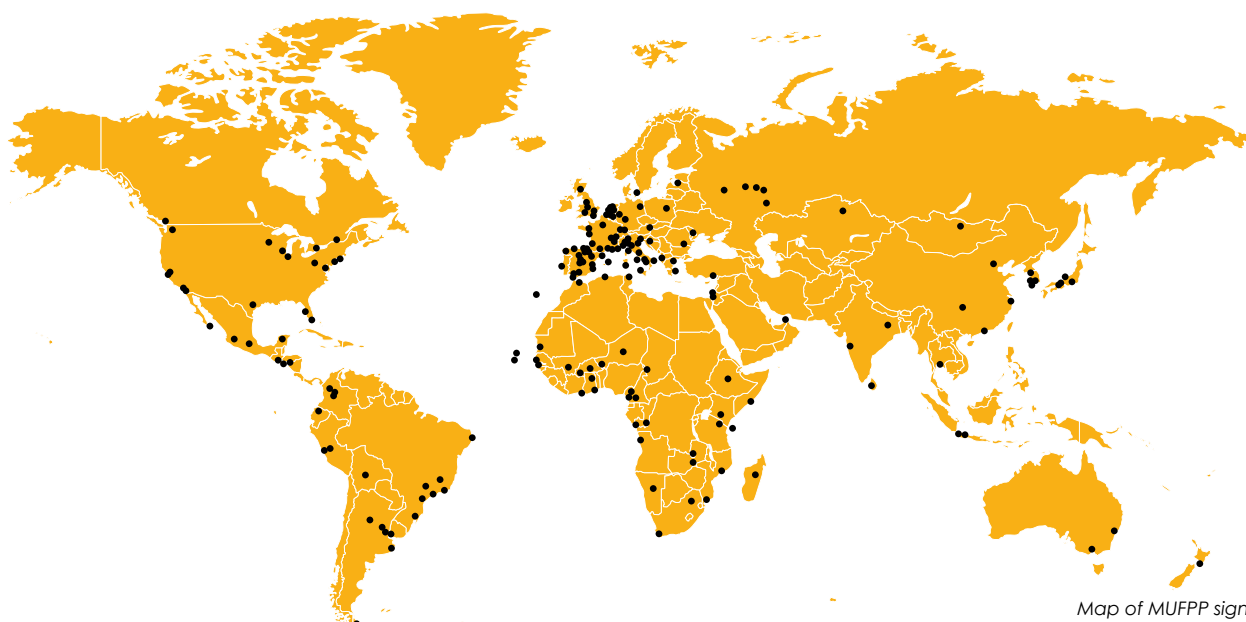

Summary

In the context of the World Sustainable Food Capital 2021, between 19th - 21st October the City of Barcelona hosted the **7th MUFPP Global Forum** on the topic of **Growing Resilience: Sustainable Food to tackle the Climate Emergency**. The Forum was an excellent opportunity for cities and partners to re-connect, exchange experiences, challenges, knowledge, and best practices after two years of virtual exchanges. In light of the critical UN Climate Change Conference (COP26) to be held in Glasgow just a couple of weeks later, the Forum represented a strategic moment to raise cities' voices on the **need for ambitious climate targets and urgent effective actions** as well as to inspire and get inspired with the shared goal of fixing our urban food systems.

Given the focus of the event, the Forum saw also the launch of **The Barcelona Challenge for Good Food and Climate**, a call for cities and their citizens to transform their food systems as a way to tackle the climate emergency. Drawing on the C40 Good Food Declaration and the Milan Urban Food Policy Pact Framework for Action, the Barcelona Challenge is a pioneering process initiated by cities leading climate actions through food policies.

The event was a great success in terms of participation, gathering **500 attendees from over 150 cities committed to food systems transformation** for further sustainability and inclusion. A key moment for our community that brought together city delegates, experts and civil society organizations from all around the world to foster cooperation and best practices' exchange. **The Forum hosted over 25 sessions**, among side events, parallel sessions and plenaries, saw the **involvement of 40 political leaders** bringing the voices of MUFPP signatory cities and benefitted of the **valuable contributions of more than 100 speakers**, both online and in-person, spurring knowledge on food system transformation.

Regional sessions were also organized to give the chance to cities to focus on their common challenges and **seek appropriate solutions for their geographical and socio-economic context**. The aim was also to reinforce the network among cities within the same region and facilitate the sharing of best practices and experiences. The Steering Committee members took the lead and shared with fellow member cities their leadership plans for the two years ahead.

This Global Forum was possible thanks to the **over 15 partner organisations and stakeholders that continuously support our work** and that helped us develop and structure such insightful sessions, presenting the great challenges as well as achievements of our signatory cities.

During these fruitful three days, there was also the opportunity to discover first-hand the excellent projects that the city of Barcelona is carrying out through several field visits. On the last night in the beautiful setting of *Museu Marítim de Barcelona* the institutional dinner was held, where Slow Food Barcelona brought together five great chefs who created a 95% vegan menu which perfectly reflected the values of our community.

The Forum was also the occasion for the announcement of the next Global Forum Hosting City: the **8th MUFPP Global Forum will be held for the first time in South America in the beautiful city of Rio de Janeiro**.

On behalf of the MUFPP community, we would like to sincerely thank Mayor Colau for the strong commitment put in the organization of the very successful 7th MUFPP Global Forum. Thanks to such a valuable moment, our community can leverage our impact worldwide.

Barcelona Challenge for Good Food and Climate

Drawing on the C40 Good Food Declaration and the Milan Urban Food Policy Pact Framework for Action, the Barcelona Challenge is a call for cities and their citizens to engage in a series of commitments related to the transformation of their food systems in order to tackle the climate emergency. The Barcelona Challenge wants to address two key issues: the mitigation of and adaptation to the climate emergency, through a commitment to transform local agri-food systems to ensure access to sufficient, sustainable, healthy and nutritious diets for all, therefore preventing food vulnerability and enhancing food justice. Based on international scientific research data, the Barcelona Challenge for Good Food and Climate presents an operational tool that allows cities to set their aspirational targets and to understand the positive impact of the urban food policies in terms of GHG emission reduction, socio-ecological benefits (prevented deaths, jobs generated, water saved) and economic return.

The Challenge counts now on the support of C40, MUFPP, Barcelona City Council, Red de Ciudades por la Agroecología, Terres en villes, Sustainable Food Places, La Fundación Daniel y Nina Carasso and RUAF.

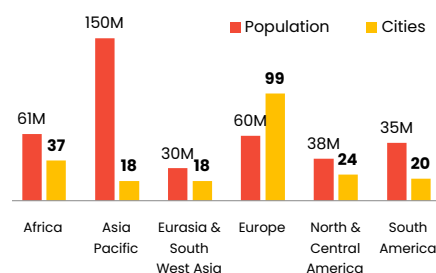
2 State of the Pact regionalisation strategies

State of the Pact

The plenary session State of the Pact and regionalisation strategies has the aim of providing an overview of the great work that the Milan Urban Food Policy Pact has been carrying out over its 6 years of activity, focusing on its evolving membership, extensive knowledge, regional and global fora and strong governance.

The Pact counts today 217 signatory cities, with 19 new additions only in 2021, representing a total of 400 million people distributed over the 6 MUFPP regions. Signatory cities are provided with a variety of tools and opportunities that they can employ as they progress on their journey towards a more sustainable and inclusive food system. The Milan Pact Awards, for example, with their 400 practices, have contributed to the creation of a common platform of food policy knowledge that continuously promotes the dissemination of innovative solutions.

Other key moments are certainly regional and global fora where cities can engage with peer cities and share opportunities with local and international stakeholders. In all of this, a pivotal role is played by the Steering Committee members that have the responsibility to lead the way and inspire signatory cities to commit to effective actions.

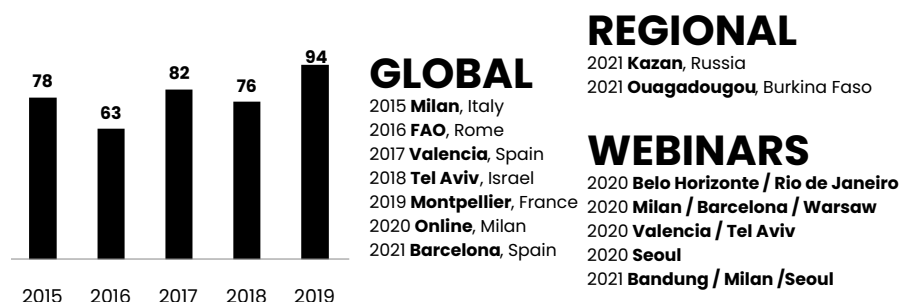

Global Fora & Hosting City 2022

Rio de Janeiro

Over the years the city has always demonstrated its commitment in the different MUFPP events and activities. During the Steering Committee meeting held in occasion of the Global Forum, the representatives of MUFPP signatory cities had to decide on the next Global Forum Hosting City. Among the 3 cities that submitted the proposals, the Steering Committee decided that the next Hosting City will be Rio de Janeiro. The city has been selected upon its great expertise on food policy innovation and consolidated experience in hosting global events, but also for the proposed theme which appeared to be well connected to international process. It will also be the first time that a Global Forum will be held in South America.

Over the last year, thanks to its meaningful relations and partnerships the MUFPP has been involved in many significant international processes. In particular, last July the MUFPP Secretariat was asked to organize a plenary session during the UNFSS Pre-Summit. The session "City and Local Food Systems" has been the only session focusing on the role of cities as key drivers of the food system transformation. It involved a great number of speakers who addressed the main concerns about the issue and highlighted the importance of bringing together different stakeholders along with the need of planning across different levels of governance to achieve the 2030 Agenda.

Besides the valuable moderation of Júlia López Ventura (C40), the session featured amazing contributions from representatives of key organizations: Gunhild Stordalen (EAT Foundation) sharing some reflections on the outcomes of the UNFSS, Marcela Villarreal (FAO) expressing how the lessons learned at global level can be exploited also in international contexts, Carmen Burbano (WFP) explaining how cities can benefit from their respective countries signing the School Meals Coalition.

EU Food Policy Strikes again

Session co-organised by **Food Trails**

Food Trails is a EU-funded Horizon 2020 project aiming to translate in Europe the Milan Urban Food Policy Pact's collective commitment to integrated urban food policies into measurable and long-term progress towards sustainable food systems. The European Commission has funded 5 Horizon consortia to innovate local food systems, involving 52 cities, on which 21 are part of MUFPP and investing 48 million euro by 2024. The side event involves representatives of the 5 projects to share approaches to co-creation of effective food policy solutions with local actions, to conclude with a round table that questions how this European experience can inspire the entire MUFPP community.

Integrated local food ecosystems to tackle climate change: URBACT's lessons

Beginner's Guide to Food Policy

The UK Food Foundation's Food Cities 2022 initiative aims to mobilise and support city authorities in ODA countries to develop and implement food policies, strategies and multi-stakeholder partnerships that aim to increase access to healthy diets and generate a positive impact of urban food systems as they respond to the COVID-19 emergency. The initiative is a learning partnership that facilitates peer-to-peer exchange and offers an online platform with tools to guide cities in developing urban food systems solutions. The session describes the key stages to initiating a Food Policy/Strategy and participating cities explain their experience of beginning the process of developing a food strategy.

5 Institutional dinner & Field visits

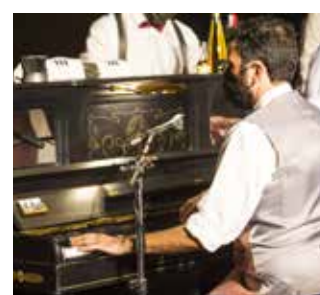
Institutional dinner

The Institutional dinner moves from the idea of creating a sustainable gastronomic experience thanks to a menu developed by 5 great chefs from Slow Food Barcelona. Their proposal consisted of a low-carbon plant-based menu, exclusively prepared with seasonal and organic food, coming from small local producers, reflecting the peri-urban and regional agro-biodiversity. Through these dishes, the chefs wanted to convey the values which we should all encourage, for the good of our people and planet.

Field vists

Barcelona History Museum MUHBA contributes to the World Capital of Sustainable Food with the exhibition "Feeding Barcelona. City, supply and health", it brings together the study of Barcelona's supply throughout its history, research on the city's hospital and healthcare history.

Fishermen's Guild of Barcelona, Marina Monsonís is a visual artist who works with social transformation processes, she offers a tour that transmits her knowledge on the types of fishing, environmental impacts, discarded and forgotten species, "trash cooking" and working people's struggles.

Sants Market, Barcelona is a city of municipal markets and these facilities have left imprint on the character of the city and its inhabitants. These municipal markets have become a benchmark of life in the neighbourhoods of Barcelona.

Can Calopa de Dalt is a publicly owned farmhouse located in the midst of the Collserola Natural Park, home to the only wine made in the city of Barcelona. The social cooperative L'Olivera runs the farmhouse, promoting organic agriculture through a social commitment.

Baix Llobregat Agrarian Park

The delta and the lower valley of the Llobregat river is an example of cultural, economic and ecological heritage located in the center of the most populated area of Catalonia. Spread over 3,300 protected and self-managed hectares, it represent the peri-urban agriculture in the city, the multifunctionality of agriculture and the role of public institutions in promotion of agricultural production.

Mercabarna, Biomarket and Centre for Food Use

Mercabarna is a major driver of the food sector in Catalonia, a veritable food city that operates year round to supply food to the public with nearly 600 companies and 7,500 workers. The visit presents the Biomarket, the first wholesale market in Spain to specialise in organic produce. The Centre for Food Use is a pioneering project in the fight against food waste. It aims to optimise the sorting of food losses and facilitate their redistribution for human consumption amongst social organisations.
